I, EVELINE THOMSON SCOTT, a resident of 21 Hoskier Road, South Orange, New Jersey, do hereby make, publish and declare this as and for my Last Will and Testament.

F I R S T :

I hereby revoke any and all wills and codicils thereto heretofore made by me.

S E C O N D :

I order and direct my Executor, hereinafter named, to pay my just debts, funeral and testamentary expenses as soon after my decease, as may be convenient.

T H I R D :

All estate, inheritance, transfer, succession, and other death taxes or duties in respect of my estate, whether upon or by reason of any bequest, legacy or devise herein provided for, or upon or by reason of any gift or transfer otherwise at any time in any manner made by me or upon or by reason of any insurance on my life (including any and all such taxes attributable to or arising out of or resulting from the inclusion in my taxable estate of any property or property right or of the value thereof), I direct be paid out of and in diminution of my residuary estate, and I hereby charge upon my said residuary estate any and all such taxes and hereby extinguish any and all right to any contribution



from or any proration or apportionment among any person or persons to reimburse my said residuary estate on account of any such taxes.

F O U R T H : .

I make the following bequests to the institutions named below and to such of the persons named below as may survive me:

(1) To MARGARET DAVIS, 6 Pond Square, Highgate Village, London, N. 6, England, 50% of the securities and funds on deposit at my death, in my name, with Glyn Mills and Co., Ltd., located at 67 Lombard Street, London, E. C. 3, England.

(2) To JUDITH KENNEDY, Hallaton Garlands Road, Leatherhead, Surrey, England, the other 50% of the securities and funds on deposit at my death, in my name, with Glyn Mills and Co., Ltd., located at 67 Lombard Street, London, E. C. 3, England.

(3) To AZNIF YAPACI, of Rumeli Hisar, Turkey, the sum of ONE THOUSAND DOLLARS (US\$1,000.00) and the cancellation of any debt she may owe me.

(4) To CHARLES and SARAH McNEAL, of Meadow Lakes, Apartment 21-08, Highstown, New Jersey, U.S.A., the sum of TWO THOUSAND DOLLARS (US\$2,000.00) in equal shares, or all to the survivor of them.

(5) To DEERFIELD ACADEMY, Deerfield, Massachusetts, U. S. A., the sum of TWO THOUSAND DOLLARS

of the Class of 1942.

(6) To FRANCES OLIVIA SEAGER, daughter of John E. Seager, of Olivet Collade, Olivet, Michigan, U. S. A., the sum of ONE THOUSAND DOLLARS (US\$1,000.00), and if she shall predecease me, to JOHN E. SEAGER, if he shall survive me.

F I F T H :

All the rest, residue and remainder of the property, real, personal and mixed, and wheresoever situate, of which I may die seized or the owner, or to which I am or may be in any manner entitled at the time of my death, I give, devise and bequeath to the TRUSTEES OF ROBERT COLLEGE OF ISTANBUL, Istanbul, Turkey, a New York corporation, in memory of my husband, Harold Lorain Scott, to be added to the Dean Scott Scholarship Fund.

S I X T H :

In addition to and not in derogation of any other powers now or hereafter conferred upon him by law, my Executor and his successor or successors are hereby authorized and empowered as follows:

(1) To settle, compromise or compound any action, suit, claim, demand or controversy in or to which I or my estate may be a party, or in any way interested.

(2) To accept and retain for my estate



any or all stocks, bonds, or other property, real or personal, or any interest therein, which I may own at the time of my death;

(3) To make division or distribution in kind or in money or partly in kind and partly in money in any case in which they are required, pursuant to the provisions of this Will, to divide into parts, portions or shares, my estate or any part, portion or share thereof, or in any case in which they are required to make any distribution of my estate or any part, portion or share thereof; the composition of any of such parts, portions or shares may differ from that of any other part, portion or share;

(4) Except to the extent prohibited by law, to cause the securities which may from time to time comprise all or any part of my estate to be registered in the name of their nominee, or to take and keep the same unregistered, and to retain them or any part thereof in such condition that they will pass by delivery;

(5) To employ custodians, agents and counsel, both legal and investment, in connection with the discharge of their duties; and they may determine and pay to such custodians, agents and counsel reasonable compensation from my estate; and they shall be entitled to reimbursement for any such compensation paid by them and for such other expenses and charges as they may deem necessary and proper to incur; and they shall determine

whether it shall be appropriate and fair to charge any such compensation, expenses or charges against principal or against income of my estate, or in part against principal and in part against income, and shall so charge the same.

S E V E N T H :

My Executor is hereby authorized and empowered generally to take such time for the liquidation of my estate and to conduct and manage the same as he may deem to be wise, without regard to the provisions of any statute or statutes relating to the time for accounting by executors or the distribution of estates, and to make all contracts and agreements in and about the management and conduct of my estate as he shall deem fit.

E I G H T H :

I appoint as Executor of this Will, THOMAS F. HUNTINGTON, now residing at 73 Allison Road, Princeton, New Jersey 09540. If he should be unable or unwilling to qualify or act as such Executor, I appoint ALFRED OGDEN, now residing at 150 East 73rd Street, New York, New York 10021 in his place and stead. I direct that no bond or security shall be required in any jurisdiction from any Executor named herein, for the faithful performance of his duties as such Executor in any jurisdiction.
